

This is a translation of BBDC's General Terms and Conditions for non-German speaking participants and guests of the BB-DanceCamp.



(Valid from 2022)

General information

These terms and conditions are valid between Boogie-Bären München e.V. (herein called "organizer") and all customers, participants and guests. These terms and conditions are valid whether a participant or guest places the order him/herself or whether it is placed by any other person in his or her name. The current revision of the terms and conditions is accessible for customers, participants, and guest online at www.bb-dancecamp.com at any given time and is applicable at the date of registration.

Particular agreements, deviating from the valid revision must be confirmed by the organizer in written or by email.

Upon registration, customers acknowledge these general terms and conditions for themselves and for all participants and guests listed in his or her order. The customer also accepts the obligation to inform all participants and guests listed in the order.

Order and Payment

Upon placement of your order, the registration tool will automatically place your it to the BB-DanceCamp booking system and is legally binding. When the organizer has received the online registration, the customer will receive a confirmation email of the booking listing all details of the order. Following to successful check of available places / tickets by the organizer, the customer will either receive a confirmation with request for payment or information that the order has been waitlisted. If no places are available, the customer will be informed and the order will be cancelled automatically. Acceptance of the order and participation is depending on receiving a confirmation of reservation. The ordering person also accepts the obligation to inform all participants and guests listed in the order.

Payment must be completed within 14 calendar days after having received the confirmation of reservation. If the organizer accepts late bookings, payment is due by the date indicated by the organizer. The applicable amount must be transferred without deduction to the organizer's account.

In case of incomplete or belated payment with respect to the above-mentioned time frame, the order will become invalid. The reservation will be cancelled and the order does no longer entitle for class bookings or evening events which were not completely paid or not paid in time.

Insufficient or late payments will be returned deductive of a fee of € 25.00.

Payment of all class fees, tickets and specials must be effected by bank transfer to Boogie-Bären e.V.'s bank account. All corresponding fees have to be paid by the customer. This applies particularly to international money transfers to Boogie-Bären's bank account. Transfers from within the SEPA zone are to be completed according to SEPA guidelines.

Cash payments at the beginning of the event are only possible by exception for important reasons. The exception has to be confirmed by the organizer upfront by e-mail.

In exceptional cases, it is possible to register after closing deadline, at the camp or after the beginning of the camp. The exception has to be approved by the organizer upfront in writing. Payment has to be done immediately in cash onsite.

Booking confirmation

Having received the payment, the organizer sends out the booking confirmation, at the latest 5 working days before the event starts. Booking confirmation for granted exceptions (see below) will be sent out to the customer at least one day before the event starts.

The booking confirmation has to be provided at camp check-in or at the door to the evening event and will be exchanged against participants' badges/tickets/hand stamps/entrance bracelets. Furthermore, in the framework of the prevention of Covid-19, respective proofs of vaccinations, recovery or Corona-testing have to be shown.

In case the customer is not able to check in every person named in the order, he will be responsible to pass on the booking confirmation to the person in question. This is also the case for participants checkin-in separately on the same order. The same rule applies for the entrance to evening events: the customer is responsible that any participant named in the order is able to show a copy of the booking confirmation on request.

Classes

The content of classes will be defined by the organizer. Information about class content is published on www.bb-dancecamp.com. In order to guarantee practicability of classes, the organizer may restrict access to classes which will be binding for all participants (e.g. minimum or maximum number of participants in a group or limitations regarding the standard of dancing skills).

The organizer may change the class schedule at any time. This may happen for several reasons, e.g. amount of students in a class or changes in teacher assignments. Any changes to class schedules and content will be published on our webpage with no delay. (see above).

In case, class schedule changes for good reasons, the organizer reserves the right to rebook ordered and paid registrations. In case of unpaid registrations, the order may be cancelled. The customer has the right to resign from the registration in case he or she is not in agreement with the change. In this unfortunate case, the cancellation has to be effected 3 days prior to the camp, at the latest. All related payments will be returned with no deduction.

In case of a change in registration or cancellation, no participant expenses will be refunded by the organizer, e.g. ticket cost.

Evening events

Information about evening events is published on the website www.bb-dancecamp.com. The organizer may change the program of the evening events, which may be necessary due to cancellations on short notice of musicians or DJs. In case of program changes, participants may not claim entrance fees.

Tickets that have been ordered and paid for will neither be refunded nor taken back.

Access to evening events is only possible after payment of the entrance fee or showing the booking confirmation or event badge/wristband.

The rules of the house are binding for all guests of the BBDC evening events. In case of severe violation of these rules, the organizer may eliminate participants (see below).

BB-DanceCamp tickets

Following tariffs and tickets apply to all BBDC with their respective conditions mentioned hereafter.

1. Early bird or regular tickets in different time stages
2. Student ticket
3. Kids ticket
4. Boogie-Bären member ticket
5. Volunteer ticket
6. Single day ticket

The following conditions are valid for all tickets mentioned above:

The customer may place a collective “group” order (for several people) as well as an order for a single person. Orders for single leader or follower need approval by the organizer and will only be confirmed if it does not impact the even distribution of leads and follows in classes. This also applies to single leader or follower registrations within group orders.

Tickets for BBDC evening events can be ordered separately (see below), or within a BBDC class registration. Entrance fees have no correlation to the fees for BBDC classes.

Referring to item 1.: early bird ticket, regular ticket

Depending on when an order is placed, early bird or regular ticket pricing applies. The organizer defines the time windows for the validity of these prices and publishes them on the website (see above). The organizer may change the deadlines for the tariffs mentioned, and will publish such changes on the website without delay.

Prices for tickets to BBDC evening events will not change during the different time windows for registration.

Referring to item 2.: Student ticket

The student ticket is valid for participants below 18 years of age*, for students and apprentices below 29 years with a valid and current student ID. A copy of the ID has to be sent to the organizer for approval prior to registration (readable scan, e.g.).

* Participation of young people under the age of 18 is only possible upon approval of their parent or legal guardian. The written approval needs to be shown when checking in. If asked, the participant has to prove the age by showing a passport or national ID card at check in.

Referring to item 3.: Kids tickets

The kids ticket applies to children and youngsters below the age of 15 when enrolling for the BBDC kids program. This package includes accommodation in the children’s tent, breakfast* as well as lunch packages* and basic care outside of the class schedule on all camp days.

*The meals mentioned are only included in the price if they are taken together with the official kids group. If children eat with their parents (e.g. have breakfast at the hotel or lunch in the restaurant), expenses for food will not be refunded and the tariff remains the same.

When choosing the kids ticket, the participant is automatically signed up for the BBDC Kids program. Additional offers or programs might need to be booked separately.

Participation of young people under the age of 18 is only possible upon approval of their parent or legal guardian. The written approval needs to be shown when checking in. If asked, the participant has to prove the age by showing a passport or national ID card at check in.

Referring to 4.: Boogie-Bären member ticket

Members of Boogie-Bären München e.V. can participate at a special Boogie-Bären fee. The membership must be valid when placing the order and throughout the BBDC. The organizer will only accept registrations using the Boogie-Bären ticket after successfully checking membership status.

Referring to item 5.: Volunteer ticket

Participants accepted by the organizer and who agree to support the BBDC with a job defined by the organizer may participate in classes outside their scheduled hours of duty at the special volunteer fee.

The respective volunteer has to send an email (for contact details see website) to the organizer (the volunteer manager) asking whether there is a job for him or her before placing an order. If this is the case, the volunteer manager assigns the volunteer to a certain job. The organizer may refuse to assign a job to the prospective volunteer if there are no or no suitable jobs available.

Participants under the age of 16 or single day participants are not allowed to take over volunteer duties and are thus excluded from the volunteer fee. Exceptions – such as when a parent or legal guardian together with a child takes a volunteer – must be discussed with the organizer before enrolling. Should this exception be granted, the organizer will confirm this via email.

Volunteers under the age of 18 need to provide a written approval by a parent or legal guardian before being accepted.

In case the volunteer fails to meet the organizer's requirements in terms of job fulfilment, the organizer may charge the delta price to the complete regular tariff. In case of missing the payment deadline a legal collection procedure will be effected.

Referring to item 6.: Single day ticket

Participants that would like to register for a single day only, can choose this option. The organizer may limit the amount of single day registrations at any time.

The single day ticket cannot be combined with the fees for students, groups or volunteers.

Before enrolling children for single days, please contact the organizer. If there are places left in the kids's group, single day participation for a child can be booked at a price which will be communicated by the organizer.

Tickets for the BBDC evening events

Tickets for the BBDC evening events may be ordered separately as well as together with regular registration to the BBDC classes.

Even if tickets for evening events are ordered without booking any classes, the ordering and confirmation process will take place as described above. Payment conditions and deadlines will be the same as for regular orders.

Tickets ordered and paid will neither be taken back nor refunded.

Participants should show the booking confirmation at the door to the evening event where it will be exchanged for a ticket/hand stamp/bracelet. The customer is responsible for every participant named in the order to be able to show a copy of the booking confirmation at the door.

Deadlines

Registration deadlines will be published on the website www.bb-dancecamp.com the day registrations can start. Registrations after the mentioned deadlines will only be accepted by the organizer in exceptional cases.

The organizer may change the deadline to an earlier date if the event is fully booked sooner.

Transfer or cancellation of participation

It is possible to transfer participation to another person. Each transfer of participation needs to be approved by the organizer by email. Any financial transfers have to be taken care of by the customer.

This also applies to individual participants who had booked within a group order. The distribution of leaders and followers within the group or collective order must not be affected by this.

Cancellations may only be placed in writing or via email four weeks before the beginning of the event at the latest and can only be done against an administrative fee of € 25.00 per participant that resigning from the order. Received payments will be reimbursed deducting this administrative fee. Any later cancellations can only be accepted after showing a medical certificate for illness or accident and the same administrative fee of € 25.00 per resigned participant will apply. If the participant cannot provide a medical certificate, the organizer is entitled to keep the entire payment.

Cancellations due to a positive Corona test at the beginning of the camp or onsite will be treated as a cancellation due to illness. The same applies for the case that the regulations for participation have changed and result in a necessary cancellation of participation. In case of a potential quarantine due to Corona, the organizer does not accept any additional costs arising from here.

When cancelling an order for classes and tickets for the BBDC evening events, the whole order becomes invalid. Partial cancellations are not possible. The customer may of course cancel and place a new order – i.e. just for classes or just for evening event tickets. In case no classes or tickets for evening events will be available anymore at this time, however, the participant is not entitled to any compensation.

Cancellations for single participants in the framework of a group order are not possible. In case of cancellations, the entire group order becomes invalid. But the customer may of course cancel and place a new group order. When placing a new group order, all the basic terms and rules mentioned earlier in these terms and conditions for group orders apply.

Rules of the House and Hygienic Concepts

By receiving the event badge (badge of camp participants, camp guest badge or ticket/hand stamp/bracelet for evening events), the participant agrees to honor the rules of the house as well as hygienic concepts of the event location and the camp. From the beginning of registration, these rules will be available on our website www.bb-dancecamp.com as well as onsite during the camp. These rules are valid for all participants as well as guests of the BBDC classes and evening events. In case of violations of these rules, the organizer may eliminate participants or guests from the premises.

Part of these rules is that participation in any of the classes or evening events is only possible when carrying appropriate ID such as the participant's badge or evening event badge or ticket/bracelet. Participants are responsible for correctly keeping and displaying the event bracelets and badges during the entirety of the

event. If a badge/bracelet has been lost, it loses its validity. The organizer has to be informed of any loss immediately. After confirming that the participant in question has the right to participate, a representative of the organizer will issue a new badge/bracelet.

Accidents

Attending classes and evening events of the BBDC is at the participants' and guests' own risk. This is particularly valid for attending aerials classes. The participant is liable for any injuries or damages incurred. The organizer is only liable for damages incurred because of premeditation or serious negligence of their representatives.

Personal belongings of participants

Boogie-Bären München e.V. is not liable in case of lost personal belongings of participants. Participants will receive back any personal belongings lost during the event which have been found and are placed in the lost and found box. In no case will the organizer forward any personal belongings by mail to the home address of the participant. Lost belongings will be removed after the camp.

Film and photography, intellectual property

We would like to inform you that our representatives will take pictures and film during the event. Films and photographic material of any persons present (participants, teachers or guests) or excerpts, compilations etc. may be published by the organizer. Further, film or photographic material may also be used for promotional and publicity purposes (i.e. website, press releases, online commercials) for the event of the following year and any subsequent years. By signing up, the client agrees to the publication of film or photographic material containing his or her picture by the organizer without compensation.

Participants may only film or photograph during the event after the explicit agreement of the teachers and only at the end of a class.

Guests may not film or take pictures during classes.

During evening events, participants and guests may only film or take pictures for private use.

Any violation will result in a penalty of €100.00. The organizer may also claim the film or photographic material without compensation. After a repeated violation, the organizer may eliminate the participant or guest from the premises. The organizer retains the use of any photographic or film material.

Data security

Information which we receive from ordering entities, participants and guest in written or electronic form are solely used for the BBDC ordering process.

By signing up, the participant agrees that he may receive marketing material related to BBDC and other external events of Boogie-Bären München e.V. via email. The participant can unsubscribe to this information at any given time.

All personal data is handled in a confidential manner. Information about the customers and participants are only passed on to official representatives of the organizer in order to organize the event. We guarantee not to pass on data to any third parties. All official representatives of the organizer have signed an agreement of data protection with the organizer.

Cancellation of the event

The organizer is exempt from having to reimburse any expenses in case of force majeure.

Effectiveness of these terms and conditions

Should some of these terms and conditions be invalid or void, the rest of the terms and conditions remain effective. A valid one shall simply replace the invalid or void clause.

Jurisdiction

For lawsuits against the event organizer, the place of business of the organizer determines the place of jurisdiction.

Applicable law

German law is applicable.

Excerpt of the

Rules of the House for

the gyms, gymnastics rooms, weightlifting room and external sports facilities

The Rules of the House apply to all participants and guests at BBDC.



I. Purpose of the gyms

(...)

II. Order and discipline

1. Please follow instructions by the municipal employees at all costs. They are representatives of the municipality and thus have property rights. Should there be no municipal employees present, the property rights are passed on to gym teachers and trainers. Please be considerate of one another in the name of fair play.
 2. Please only enter the gym wearing **sportswear** and **clean sports shoes which do not rub off on the floor**. Please use the locker rooms reserved for this purpose to change clothes and shoes.
 3. Showers and washing facilities are available. Please keep them as well as the toilets clean.
- (...)

III. Safety and usage

1. **smoking and the consumption of alcohol is prohibited** in the entire building.
(Addition by the organizers of the event: Alcohol is strictly prohibited particularly during classes.)
2. (...) Users may not take bottles, drinks, food, chewing gum etc. into the gyms.
3. Only after the explicit agreement of the municipality of Landsberg may users conduct publicity of any kind (including announcements and distribution of flyers). Posters for sports events are an exception to this, but may only be put up in the places provided expressly for this purpose.
4. The janitorial facilities are not to be accessed; users may not park bicycles inside.
5. (...)
6. **When transporting equipment, users should refrain from damaging the floors, walls and doors of the gyms.** The equipment (including gym mats) has to be carried or carted from place to place. Climbing ropes are not to be knotted to prevent accidents; magnesia has to be kept in containers. **It is forbidden to use adhesive media such as resin or others. When there are competitions, games or other events, the hosting club (or other users) has to guarantee this also for other clubs (users).**

IV. Liability

(...)

1. The user is liable to the municipality for any damages resulting from using the facilities, equipment and access paths within the scope of these terms of use. (...)

V. Teachers and lessons

1. It is forbidden to enter the gym without a trainer or teacher present. (...)

VI. Breach of the terms of use

1. Representatives of the municipality are allowed to supervise the compliance to the terms of use. They are allowed and ought to evict users from the gym who breach the terms of use. (...)

VII. Lost & Found

1. The municipality shall not be liable for lost clothes, valuables, sports club equipment or private items. (...)

VIII. General information

1. By entering the gym, each user accepts the existing terms and conditions without exceptions. The terms of use are posted at appropriate locations in the different gyms.
2. The lights and heating are controlled electronically, only qualified personnel is allowed to make any changes to the system.
3. (...)
4. Rules and condition are subject to changes.
5. These terms of use are also valid for all sports facilities.
6. Place of fulfilment and place of jurisdiction is Landsberg am Lech.
